RESOLUTION ESTABLISHING SANITATION FEES FOR TRANSFER STATION

WHEREAS, for health and safety considerations, the Board of Councilmen has selected a disposal site for residential use and for limited commercial use and given approval for sanitary methods of storing dry waste and debris prior to removal and transfer from the City by a permitted private collector; and

WHEREAS, the Board desires to encourage recycling of metals, waste oil and paper products; and

WHEREAS, this transfer disposal site will be operated in accordance with Nevada Division of Environmental Protection standards and is not for the storage of wet (household) garbage, toxic or hazardous waste or other unacceptable materials; and

WHEREAS, the Board of Councilmen has determined that this disposal site should be made available to residents who live in close proximity but do not reside in within the City limits, and

WHEREAS, there is a cost associated with providing this service and the Board desires that all users bear this cost, not just the residents of the City of Wells,

NOW, THEREFORE BE IT RESOLVED AND ORDERED BY THE BOARD OF COUNCILMEN THAT the following fees are established for the transfer disposal site.
