

Upon introduction and motion by Councilman _____, a second by Councilman _____, the following resolution was duly passed and adopted:

**CITY OF WELLS
RESOLUTION NO. 19-04**

A RESOLUTION ESTABLISHING BUILDING VALUATIONS AND AMENDING BUILDING PERMIT FEES PURSUANT TO WELLS CITY CODE, TITLE 4 BUILDING CODES , CHAPTER 4 SECTION 4-1-4

WHEREAS, the Wells City Code Title 4, provides that the Wells City Council sets the fees charged for the building permits by resolution; and

WHEREAS, to establish minimum building valuations; and

WHEREAS, to establish procedures to simplify the building permits fee calculations; and

WHEREAS, to set a minimum permit fee to offset actual permit processing cost

NOW, THEREFORRE BE IT RESOLVED AND ORDERD, by the Wells City Council that the following building valuation tables and fee schedules be adopted until further actions taken by the Wells City Council to amend delete or otherwise change the same.

BUILDING PERMIT FEES

The minimum charge, per permit/Application number issues is \$43.50
(Permit charge consists of a Processing Fee of \$20. + Permit Fee of \$23.50)
