### PLEDGE OF ALLEGIANCE

Mayor Pollock led everyone in the Pledge of Allegiance.

### APPROVAL OF MINUTES OF PREVIOUS MEETINGS

Micheli made a motion to approve meeting minutes dated July 25, 2023. DelRio provided the second and motion passed unanimously.

### CITIZENS TO ADDRESS THE COUNCIL

There were none.

REPORT FROM ELKO COUNTY SHERIFFS OFFICE ON APPLICATION FOR BROTHEL LICENSE FOR DAVID ARMSTRONG TO PURCHASE BELLA'S HACIENDA RANCH

Minutes of Wells City Council Meeting of August 8, 2023 Lt. Fisher reported that the investigation based on the information that was provided was completed on July 19, 2023. A portion of the documentation provided was not signed and notarized. Armstrong was informed that portion was still outstanding. Fisher had a conversation with Armstrong on July 24<sup>th</sup> stating the ECSO was done with what was submitted. Mr. Armstrong indicated that he and Bella were still in negotiations and had not concluded their financial transaction and asked for another 60 to 90 days to complete the financial transaction. Fisher informed Armstrong to make sure he had provided the complete documentation as far as being signed and notarized. At this point in time, based on the documentation, ECSO is done and just waiting to see if the individuals will move forward with the sale of the business or if the deal will not go through.

### BETTER CITY PRESENTATION TO UPDATE THE BOARD OF COUNCIL

Eric Gibson and Rachel Boyett from Better City were at the meeting to show the board the new City of Wells website Better City has been working on. The website was available for everyone to see and Boyett went through the design. Some of the pictures will be updated. Boyett asked if there were any changes anyone had before it was ready to be launched? Gibson stated the link will be sent to the council members to pull up on their phone and personal devices as it looked washed out. Gibson added pictures will be taken of the different lots available in the industrial park tomorrow.

# DISCUSSION TO RECEIVE CDBG GRANT APPLICATION IDEAS FOR THE UPCOMING GRANT CYCLE TO BE SUBMITTED TO CDBG FOR ELIGIBILITY APPROVAL

Pollock began that the new senior center is his priority for grant funding. DelRio agreed that the senior center is a priority but would also like to see the splash pad revisited. Pengelly will discuss the splash pad in his report. DelRio continued that two years ago, Scott Stewart drew up plans for the park and would like to see the basketball courts revisited as well. There are kids there every day. One of the hoops faces the street and is dangerous. Pengelly stated that it would be easy to put a basketball court there. DelRio didn't think it would be a big expenditure and would make a difference. Pollock stated that pickleball is also a popular activity that might go along with the basketball court.

# DISCUSSION AND POSSIBLE ACTION TO APPROVE A PROCLAMATION DECLARING THE MONTH OF SEPTEMBER AS CHILDHOOD CANCER AWARENESS MONTH

Pollock read the proclamation. DelRio asked what this would entail. Nance stated that proclamations that are adopted from different cities may help Northern Nevada Children's Cancer Foundation receive more funding. DelRio made a motion to approve the proclamation declaring the month of September as childhood cancer awareness month. Micheli provided the second and motion passed unanimously.

### DISCUSSION AND POSSIBLE ACTION TO ADVERTISE FOR PROPOSALS FOR THE AIRPORT CONSULTANTS

Minutes of Wells City Council Meeting of August 8, 2023 Pengelly stated that Armstrong is our current airport consultant and their five-year contract is coming to an end soon. The city needs to advertise to request RFQ's for other potential firms. Armstrong has done a good job for the last five years. Once the RFQ's are advertised and received, the board will review them and decide who will be the airport consultant. Micheli made a motion to advertise for proposals for the airport consultants. DelRio provided the second and motion passed unanimously.

### CLAIMS COMMITTEE REPORT: ACTION TO APPROVE FINANCIAL STATEMENTS

Micheli made a motion to approve the Warrant Register dated July 27, 2023 through August 8, 2023 in the amount of \$97,006.79. DelRio provided the second and motion passed unanimously. Micheli made a motion to approve the check register dated July 1, 2023 through July 31, 2023 in the amount of \$32,316.15. DelRio provided the second and motion passed unanimously.

### COUNCILMEN'S REPORTS

Micheli reported that the car show went well and there was a good turnout.

DelRio stated that sports are up and running and getting ready for the school year. The 4-H kids are working hard and went to Elko today to promote the auction held during the fair for the animals the 4-H kids have raised.

Pollock thought the car show was good and helped at the senior center breakfast both mornings. Pollock also did the mayor's choice plaque for the 31<sup>st</sup> car show. The city was informed by NGM that the city had been awarded \$300,000 payable over two years for the new senior center. The city can't thank them enough and makes the completion of that building so much closer.

### STAFF REPORTS

Pengelly mentioned the auditors will be here the end of the month. A letter from Eide Bailly was given to each council member and is something provided every year. The mayor will need to sign it and send it back.

A grant has been applied for with Nevada Parks & Recreation for a splash pad. Pengelly will have a meeting regarding this grant on Thursday. There is an issue with some property that was given to the city by NPR a long time ago. There are two parcels that were granted to the city for the golf course and the city flipped two parcels' years ago and this needs to be addressed. If that is resolved, the city could still be eligible for the grant.

Nance and Pengelly met with NDP stormwater regarding Shoshone Avenue. NDP will fund the entire project for \$675,000. The Shoshone Avenue project will receive 1.2 million dollars for the project that will be completed next year. Work is being done on the environmental and the construction drawings.

Minutes of Wells City Council Meeting of August 8, 2023 Pengelly stated knowing the amount NGM will give towards the new senior center will help know how much will be needed from CDBG for the grant.

Nance found an aging and disability grant that will help fund new kitchen equipment for the new senior center. The new tables came today that were purchased with money from the \$4,000 received from the WREC Next Dollar Foundation and chairs will be coming.

The TAP grant in the amount of one million dollars for Lake Avenue has also been applied for but have not heard back on it yet.

### CITIZENS TO ADDRESS THE COUNCIL

Nicole Rodriguez mentioned that every summer, Hogan Street becomes a speedway even by residents who live on that street. Rodriguez wondered if a speedbump could be put in to slow people down. Pengelly stated he could contact the ECSO to patrol that area more. Pengelly stated it is not just Hogan, it is everywhere.

### **ORDINANCE NO. 242**

### AN EMERGENCY ORDINANCE AMENDING TITLE 3, CHAPTER 6 OF THE WELLS CITY CODE

**WHEREAS**, the Title 3, Section 6 of the Wells City Code requires that medical examinations be done by or under the supervision of a licensed physician;

**WHEREAS**, the City of Wells does not have a licensed physician practicing medicine in the City;

**WHEREAS**, an advanced practice registered nurse, nurse practitioner, does work in the City, and may perform said examinations without the supervision of a physician, pursuant to state law;

WHEREAS, pursuant to Sections 2.060 and 2.110 of the Wells City Charter, the City Council is authorized, by unanimous consent, to take final action to immediately enact ordinances in cases of emergency, subject to the provisions of Chapter 241 of NRS;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WELLS, NEVADA.

Section 1: That Title 3, Chapters 6, Section 21 of the Wells City Code is amended as follows:

### 3-6-21: MEDICAL EXAMINATIONS; DUTY OF LICENSEE:

Every licensee shall ensure that every prostitute is examined by a physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state, as required in section <u>3-6-28</u> of this chapter, and that the physician has:

- A. Issued to every person examined and found not to be afflicted with a sexually transmitted disease, a certificate so stating;
- B. Refused to issue such certificate to any person found to be, or suspected of being, afflicted with a sexually transmitted disease;
- C. Reported the results of such examinations weekly to the chief of police or his designee at such time as the chief shall set in writing to the board;
- D. Reported to the board immediately the existence of any condition on the premises of any licensed operation which, in the professional opinion of the physician, constitutes a health hazard to the patrons or employees of any licensed operation or to the public, together with his recommendations for correcting the condition.

Section 2: That Title 3, Chapters 6, Section 28 of the Wells City Code is amended as follows:

### 3-6-28: MEDICAL EXAMINATION REQUIRED OF ALL PROSTITUTES:

- A. Every licensee shall require and ensure that the rules and regulations now in force or hereafter promulgated by the division of health of the department of human resources of the state of Nevada are complied with and that medical examinations are undergone by all prostitutes working at the licensee's operation, which examinations shall:
- 1. Be performed at least once a week. These medical examinations must be completed and the examination results available by each Friday of the week prior to medical exam record checks being conducted by the police department.
- 2. Be performed by or under the supervision of a physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state or doctor of osteopathy duly licensed to practice medicine in the state.
- 3. Include all tests specified by the division of health of the Nevada department of human resources for the detection and diagnosis of sexually transmitted diseases including, but not limited to, weekly tests for gonorrhea and chlamydia and a monthly blood test for syphilis and human immunodeficiency virus (HIV), which shall be processed at a licensed and approved clinical laboratory.
- 4. Include monthly tests approved by the division of health of the department of human resources of the state for the detection of HIV. Appropriate specimens are to be submitted to and processed at a licensed and approved medical laboratory.
- 5. Include other medically approved tests, deemed advisable by the physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state, for determining whether the prostitute is afflicted with any infectious or contagious disease.
- 6. Be performed at the location of the licensed operation, at the physician's or advanced practice nurse, nurse practitioner's office, at a hospital or clinic, as determined by the physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state.
- 7. Consistent with NAC 441A.120(2), no person may work as a prostitute in a licensed house of prostitution until a state licensed and approved medical laboratory has reported that the results of the tests required by NAC 441A800 et seq., do not show the presence of chlamydia, syphilis, gonorrhea, or the antibody to the human immunodeficiency virus. In effect, no prostitutes will be allowed to work (perform sexual acts with another person) on the premises until they have been cleared by a physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice

medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state, to work.

- 8. If any prostitute's test results are positive, the prostitute must be removed from the brothel floor immediately and her work card turned over to a representative of the police department. The prostitute must wait at the brothel until contact is made by the state health department or its designee. This contact may be made in person or by telephone. Once contact is complete, the prostitute may then leave the premises of the brothel. If the prostitute chooses to stay, she will remain off the floor, which includes the bar area, and not engage in any type of sexual activity until a clearance to return to work has been received from the physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state, and presented to the police department.
- 9. The owner/management or key employee of the brothel is required to notify the police department when a prostitute leaves the brothel on vacation. (Any period in excess of 48 hours is considered vacation.) Prior to returning to work from vacation, the prostitute must get a medical exam, clearance from a physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state, and cleared to go to work by the Wells police department.
- B. After performing the examination required in subsection A of this section, the examining doctor shall:
- 1. Issue to every person examined and found not to be afflicted with a sexually transmitted disease or other contagious or infectious disease, a certificate so stating.
- 2. Refuse to issue such certificate to any person found to be, or suspected of being, afflicted with a sexually transmitted disease or other contagious or infectious disease.
  - 3. Report the results of such examinations weekly to the chief of police or his designee.
- 4. If any prostitute examined is found to be afflicted with a sexually transmitted disease or any contagious or infectious disease that creates a health hazard, the doctor shall immediately notify the chief of police or his designee and the licensed operator where the prostitute is working, of such condition.
- C. No person may work as a prostitute in any operation without a current certificate, as described in subsection B1 of this section.
- D. No person who has ever been denied a certificate by an examining physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state, or doctor of osteopathy, as provided in subsection B2 of this section, may again work as a prostitute in any licensed operation until such person has received and presented to the chief of police or his designee a certificate from an examining physician licensed to practice medicine in the state, or by a physician's assistant or registered nurse under the authority of a physician licensed to practice medicine in the state, or an advanced practice registered nurse, nurse practitioner, licensed in the state, or doctor of osteopathy stating

that the cause or causes which resulted in the denial of the certificate have been cured and that the person is now free of any sexually transmitted disease or other contagious or infectious diseases.

- E. Nothing contained in subsections A through E inclusive of this section shall prevent the board on its own motion or upon complaints or reports from any person, from inquiring into the existence of any condition on the premises of any licensed operation which might constitute or cause a health hazard. (Ord. 192, 6-26-2001)
- **Section 3:** All ordinances or parts of ordinances in conflict herewith are hereby repealed, but only to the extent of such conflict.
- **Section 4:** If any section, paragraph, clause, or provision of this ordinance shall for any reason be held to be invalid, unenforceable, or unconstitutional by a court of competent jurisdiction, the invalidity, unenforceability, or provision shall not affect any remaining provisions of this ordinance.
- **Section 5:** Upon adoption, the City Clerk of the City of Wells is hereby directed to have this ordinance published by title only, together with the Councilman voting for or against its passage in a newspaper of general circulation within the time established by law, for at least one publication.
