

Upon introduction and motion by Councilmen Savedra, a second by Councilmen Peltier the following resolution was duly passed and adopted:

**CITY OF WELLS  
RESOLUTION 25-06**

**RESOLUTION ESTABLISHING GOLF COURSE FEES AND MATTERS  
PROPERLY RELATING THERETO**

**WHEREAS**, Section 2.220, Wells City Charter, provides that the Board of Councilmen of the City of Wells may maintain any golf course, driving range, clubhouse, pro shop and other facility related thereto; and

**WHEREAS**, the Board of Councilmen has determined that the establishment of fees associated with the golf course is necessary for the maintenance of the golf course,

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED THAT** the following fees are established.

Season Passes

Adult	\$ 310.00
Senior Adult (Minimum age 62)	\$ 210.00
Couples	\$ 465.00
Senior Couples (At least one person minimum age 62)	\$ 350.00
Family (Children 18 and under)	\$ 535.00
Junior (18 and under)	\$ 80.00
College (Age 18 – 24, minimum 6 units per semester)	\$ 150.00

Season Passes are effective from April 15 through April 14 of the following year. Those not remitting pass fees by April 15 of the following year will be subject to daily rates.

Season Passes Payment Plan

Membership payment plan is available for all season passes. Payments will be made in three monthly payments. Payments are due on the 1<sup>st</sup> open for business day of each month at City Hall or Golf Course if open. Daily green fees will be charged if payments have not been made as required. Paid money will be forfeited. Admittance will be April 1<sup>st</sup> from March 31<sup>st</sup> of the following year

**Rain Check Policy:**

If you begin to golf when it is already raining, no Rain Check will be given. If you have paid for 9 Holes, have completed four holes or less and it begins to rain, a Rain Check will be given. If you have paid for 18 Holes, have completed thirteen holes or less and it begins to rain, a Rain Check will be given. Rain Checks shall expire thirty (30) days after issue.

**Punch Passes**

10 Rounds 9 Holes	\$	150.00
20 Rounds 18 Holes	\$	250.00

Punch Passes are good for 1 year from date of purchase and are to be in possession of golfer. Full purchase credit (\$) will be given if an individual desires to convert a Punch Pass to a Season Pass within thirty (30) days of initial purchase.

**Tournament Rate Fees**

Tournament Rate Fees applies to individuals that play in are tournament that do not have a season pass. Most tournaments are 18 holes per day.

All Annual Cart Storage Fees are due by April 15 each year. For Cart Storage Fees paid between April 16 and May 15, an additional \$25.00 will be charged. Cart Storage is non-transferrable. Cart Storage openings will be filled from a list of interested parties maintained at City Hall on a first come, first serve basis.

\$50 will be refunded by City Hall within one week after date of event if party areas are cleaned to the satisfaction of the Golf Pro. Party or event may be extended beyond the 3 hour limit at a rate of \$75 per hour which may be waived at the Golf Pro's discretion contingent on sales during the party.

Scheduling is dependent on Golf Professional/City Manager's approval. Activities directly related to golf will not have a charge to include meals, Calcutta's, golf trainings, and golf awards activities, however, sundry activities such as auctions that benefit non-golf organizations may. Any activities not in association with golf will be subject to fees to include private parties, funerals, weddings, meetings, political greetings and catered events etc. this fee cover maintenance, utilities, wear & tear, and toiletries.

Golf Shop Merchandise

Cost of merchandises, plus freight, and fifty percent (50%) mark up

Golf Course Bar and Café

Cost of beverage, supplies, plus minimum average of sixty percent (60%)

Cost of food, supplies, plus minimum of thirty five percent (35%)

**THAT** all fees are nonrefundable.

**THAT** the fees provided by this resolution are not an exclusive list of all fees for all services provided by the City of Wells, and any fee heretofore established for any other license, permit or service shall remain in full force and effect.


**THAT** all orders, resolution or parts thereof in conflict with this Resolution are hereby repealed.

**THIS** Resolution shall become effective on March 25, 2025.
